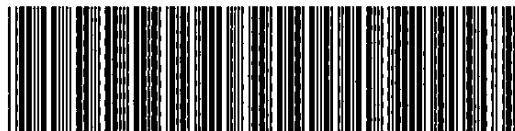

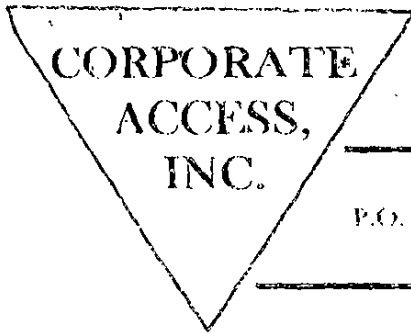

The undersigned incorporator to these Articles of Incorporation, being duly licensed to practice medicine under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

**ARTICLE I - NAME**

The name of the professional service corporation is CARIFI BREAST CARE, P.A.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 128 Lake Region Circle, Winter Haven, Florida 33881.

**ARTICLE III - PURPOSE**

The professional service corporation is formed to engage in every phase and aspect of the practice of medicine. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds or any other type of investment, and own real and personal property necessary for the rendering of professional services.

**ARTICLE IV - TERM OF EXISTENCE**

The professional service corporation shall have perpetual existence starting on the date this Articles of Incorporation are filed with the Florida Department of State.

**ARTICLE V - CAPITAL STOCK**

This professional service corporation will have one class of stock and is authorized to have outstanding 10,000 shares (with a par value of \$1.00 per share) at any one time.

None of the shares of the professional service corporation may be issued to anyone

other than an individual duly licensed to practice medicine in the State of Florida.

**ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE VII - INITIAL BOARD OF DIRECTORS**

There shall be a Board of Directors for this professional service corporation, which shall consist of one (1) Director initially. 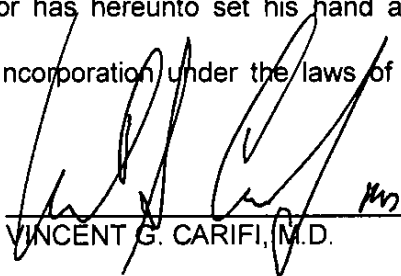

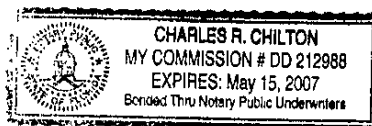
