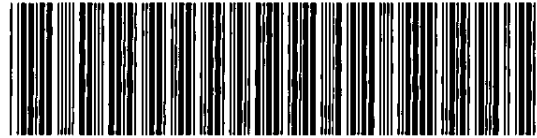

ORDER

THIS CAUSE having come before the Court on JORGE FERNANDEZ' ("FERNANDEZ") Motion to Dissolve Corporations and Voidance of Fraudulent Transfers, and the Court having heard argument of counsel, and being otherwise fully advised in the premises:

This Court makes the following findings of fact:

- 1) This Court has subject matter and personal jurisdiction over the Defendants.
- 2) This Court GRANTED said Motion on November 19, 2007.
- 3) The Defendants have been dully served in this matter and have failed to file any responsive pleadings.
- 4) The Complaint is Verified and that Defendant FREDDY A. ALFARO incorporated 4 VIHAS EXPRESS SERVICE, INC. at the same location with the same phone numbers as 4 VIHAS INTERNATIONAL, INC. a Florida Corporation, d/b/a 4

VIHA'S CARGO AND LOGISTICS, 4 VIHASBOX INTERNATIONAL, INC.; while being an Officer and Shareholder of same.

Based on the aforementioned findings of fact it is hereupon,

ORDERED AND ADJUDGED as follows:

→ A) The State of Florida, Secretary of State, Department of Corporations ("The Department") shall judicially dissolve the Following:

i) 4 VIHA'S INTERNATIONAL, INC. a Florida Corporation, d/b/a 4 VIHA'S CARGO AND LOGISTICS,

ii) VIHASBOX INTERNATIONAL, INC. a Florida Corporation, and

iii) 4 VIHA'S EXPRESS SERVICE, INC., a Florida corporation, within 30 days from the date of this ORDER and provide proof of same to Plaintiff.

→ iv) The Department is hereby instructed to void the status of the fictitious name of 4 VIHA'S CARGO & LOGISTICS forthwith by Order of this Court within the 30 days.

B) All transfers of any assets are herein voided as a matter of law. The Defendants are herein instructed to transfer back any property transferred since June 1, 2007.

C) The Defendants are liable to the Plaintiff for damages as a matter of law.

i) Plaintiff shall specially notice same for hearing as to the determination of damages, if any.

D) The Court retains jurisdiction over the matters herein adjudicated to enforce any future violations of this Order.
