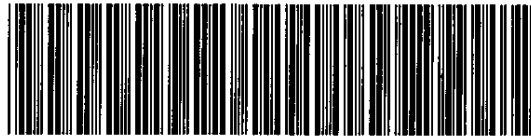



**Indemnification**

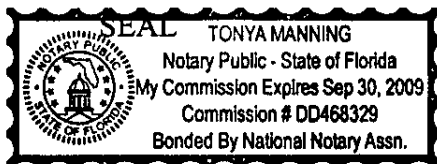
