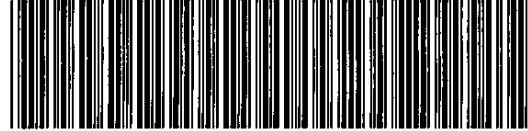



**ARTICLES OF INCORPORATION  
OF**

**THE SIMS CHRISTOPHER GROUP, INC.**

**ARTICLE I:** The name of this corporation is **THE SIMS CHRISTOPHER GROUP, INC.**

**ARTICLE II:** This corporation shall have perpetual existence.

**ARTICLE III:** This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States or the State of Florida.

**ARTICLE IV:** The maximum number and class of shares of capital stock which this corporation is authorized to have outstanding is one hundred shares of common capital stock with a par value of One Dollar (\$1.00) per share.

**ARTICLE V:** The initial principal office of this corporation shall be at, 103 Duck Bill Cove, Ponte Vedra Beach, Florida 32082, and the name of the corporation's initial registered agent at that address is SIMS R. ROGERS.

**ARTICLE VI:** Initially, this corporation shall have one member on the Board of Directors. the approval of the shareholders, to issue "Section 1244 Stock" as defined by Section 1244 of the Internal Revenue Code as the same may be amended from time-to-time.

Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders and approved at a shareholders' meeting by a majority of the stock entitled to vote thereon unless all of the Directors and all of the shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.




