
ARTICLE X

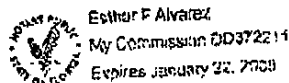


