ARTICLES OF INCORPORATION
OF
CARSON DIVE SYSTEMS, INC.
A FLORIDA CORPORATION

The undersigned, acting as Incorporator of CARSON DIVE SYSTEMS, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of the Corporation is CARSON DIVE SYSTEMS, INC. and the street address of the initial principal office of the Corporation is 6533 Grande Orchid Way, Delray Beach, FL 33446.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue One Hundred Thousand (100,000) shares of \$.001 par value Common Stock.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 120 E. Palmetto Park Road, Suite 450, Boca Raton, FL 33432, and the name of the initial Registered Agent of the Corporation at that address is Redgrave & Rosenthal LLP.

The Corporation shall initially have one director to hold office until the first Annual Meeting of Shareholders and until his successor has been duly elected and qualified, or until his earlier resignation, removal from office or death. 


