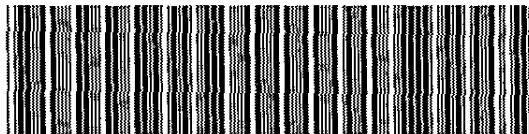

**ARTICLES OF INCORPORATION OF POLO FURNITURE, INC.**

The undersigned incorporators for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopt the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this corporation is **Polo Furniture, Inc.** (hereinafter referred to as the "Corporation")

**ARTICLE II - PRINCIPAL OFFICE**

The initial address of the principal office of this Corporation is **328 Crandon Boulevard, Suite 112, Key Biscayne, Florida 33149** and the initial mailing address of this Corporation shall be **328 Crandon Boulevard, Suite 112, Key Biscayne, Florida 33149**

**ARTICLE III - DURATION**

This Corporation shall have perpetual existence.

**ARTICLE IV - PURPOSE**

The primary purpose of this Corporation is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE V - CAPITAL STOCK**

Notwithstanding, anything in these Articles of Incorporation, this Corporation is authorized to issue only one class of stock and such stock shall be designated as common stock.

#### **ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT**

The name of the initial registered agent of this corporation is **Carlos Leonardo Polo, 328 Crandon Boulevard, Suite 112, Key Biscayne, Florida 33149**, upon whom process in any action or proceeding against this Corporation may be served.

#### **ARTICLE VII - INITIAL BOARD OF DIRECTORS**

This Corporation shall have two (2) initial Directors on the initial Board of Directors this Corporation.

The initial Directors on the initial Board of Directors shall remain on the initial Board of Directors until the first election of the Board of Directors to be held in the manner and at the point in time prescribed by the bylaws adopted by this Corporation as amended from time to time. The number of directors may be increased or decreased from time to time on accordance with the by laws adopted by this Corporation as amended from time to time. Notwithstanding anything in these Articles of Incorporation, the number of Directors on the Board of Directors shall never be less than one (1). 
