ARTICLE I

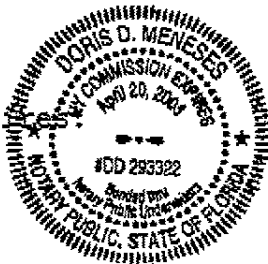
