

Pursuant to Section 607.1105, Florida Statutes, Reliable of Miami Inc., a Florida for-profit corporation, and CAW Rentals, Inc., a Florida for-profit corporation, hereby, pursuant to the unanimous vote of their stockholders, at joint meeting held April 11, 2011, merge the two [2] corporations into one [1] with the surviving corporation being CAW Rentals, Inc.


MERGER DATE


STOCKHOLDERS VOTE ON MERGER
