ARTICLES OF INCORPORATION OF ENCOMPASS TITLE, INC.

The undersigned, acting as incorporator of ENCOMPASS TITLE, INC., adopts the following Articles of Incorporation to form a for profit corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is: ENCOMPASS TITLE, INC.
