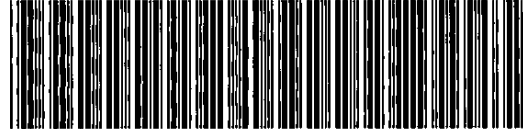

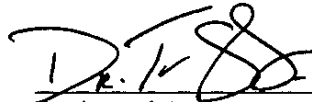
Article VII -- Registered Agent

Article XIII – Amendment

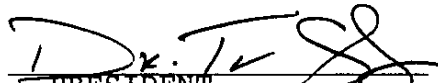

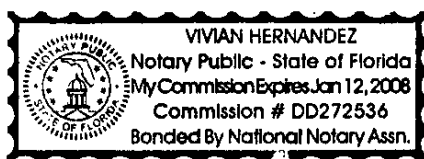
