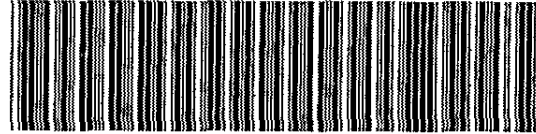

CAPITAL STOCK


