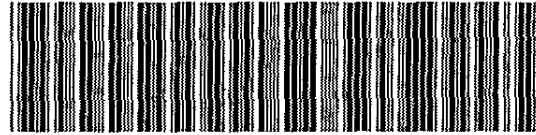



ARTICLE I

Name of the Corporation




