CONTROL SHARE ACQUISITIONS

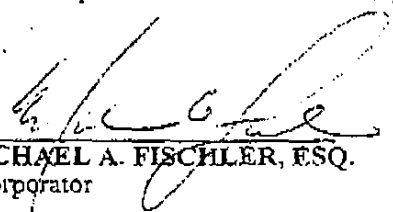
