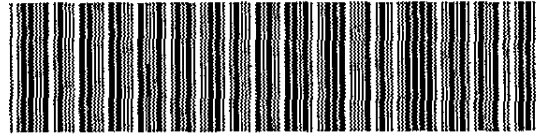

The name of this corporation is MID-STATE SANITARY SUPPLY, INC. -

ARTICLE X. AMENDMENT

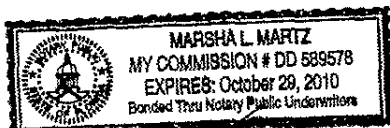
The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.
