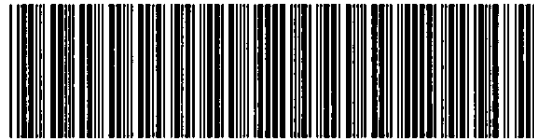

ARTICLE IX. AMENDMENT
