## Articles of Incorporation of WORLD FINANCIAL CONSULTING, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

#### Article I - Name

The name of the corporation shall be: World Financial Consulting, Inc.

#### Article II - Commencement & Duration

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.

#### Article III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

#### Article IV - Capital Stock

The corporation shall have the authority to issue par value shares of common capital stock: 100 shares \$1.00 par value.

#### Article V. Preemptive Rights

#### Article VI Transfer Restrictions

No shareholder shall have the right to sail, assign, pledge, encumber, transfer or otherwise dispose of any shares of the capital stock of this corporation, without first offering such shares for sale to this corporation at the net asset value thereof. Such offer shall be in writing, signed by the shareholder, sent by registered or certified mail to this corporation at its registered office address, and open for acceptance by this corporation for a period of fifteen days from the date of mailing. If this corporation fails or refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of such shares without any further restrictions:

On the death of any shareholder, this corporation shall have the right to purchase any shares of the capital stock of this corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.
