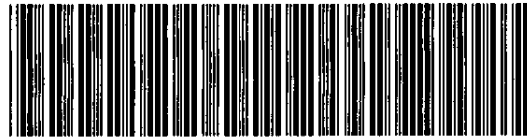

Danisleidys Patten shall be Director, President and Secretary of the corporation.


