ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is: TAURUS METAL RECYCLING, INC.

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the Shareholders.
