ARTICLE 1: CORPORATE NAME: The name of this corporation is DAMIAN ANTHONY JAMES, P.A.

ARTICLE 2: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS: The street address of the initial principal place of business of this corporation and the initial mailing address of this corporation is 661 NE 60 Street, Miami, FL 33137.

ARTICLE 3.
