PURSUANT TO CHAPTER 48.091, FLORIDA STATUTES CATHERINE CIULLO OF 4807 CHALFONT DRIVE, ORLANDO, FLORIDA 32837-5059 IS HEREBY NAMED AS REGISTERED AGENT OF THIS CORPORATION TO ACCEPT SERVICE OF PROCESS WITHIN THE STATE OF FLORIDA. THAT CATHERINE CIULLO BY EXECUTION OF THESE ARTICLES DOES ACCEPT TO ACT IN THIS CAPACITY AND AGREE TO COMPLY WITH THE PROVISIONS OF SAID ACT RELATIVE TO KEEPING OPEN SAID OFFICE LOCATED AT THE ABOVE ADDRESS.

ARTICLE X
