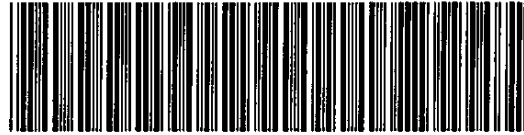

ARTICLE I: NAME

The name of this Corporation shall be:

GRAHAM INSTALLATION, INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE
