The undersigned hereby forms a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

1. Name. The name of this corporation is Tara Kali Design Interiors, Inc.
2. Nature, Purpose and Powers. This corporation shall have perpetual existence, commencing on execution and acknowledgment of these Articles, and have the power to be a general or limited partner in any domestic or foreign limited or general partnership and carry out all duties of the general partner as provided in Chapter 620, Florida Statutes, engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.
3. Capital Stock. The maximum number of shares that this corporation is authorized to issue and have outstanding at any one time is 10,000 shares of \$1.00 par value common stock. Shares may be issued only for consideration having value, in the judgment of the Board of Directors, at least equivalent to the full par value of the stock to be issued; and, on issue shall be fully paid and nonassessable.

5. Initial Board of Directors. This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by the Bylaws but shall never be less than one. 

