# ARTICLES OF INCORPORATION

OF

**BARNEY B. AVCHEN, P.A.**

The undersigned natural person, being licensed to practice the profession of medicine in the State of Florida, hereby declares the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation.

## ARTICLE I. NAME

The name of the corporation is BARNEY B. AVCHEN, P.A.

## ARTICLE II. PURPOSE

This corporation is organized for the following purposes:

- a. To engage in the practice of law as a professional corporation.
- b. To promote the legal profession and services to the public; and to own real and personal property, enter into contracts, and to engage in any lawful business necessary for the rendering of such professional services.
- c. To do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is duly licensed or otherwise legally qualified to render professional legal services in the State of Florida.

## ARTICLE III. CAPITAL STOCK


The total number of shares of capital stock which the corporation shall be authorized to issue is ONE THOUSAND (1,000) shares. Such shares shall be of a single class of common stock and shall have a par value of ONE (\$1.00) DOLLAR per share.

## ARTICLE IV. CAPITALIZATION

The amount of capital with which the corporation will begin to practice the legal profession is not less than FIVE HUNDRED (\$500.00) DOLLARS.

## ARTICLE V. DURATION

The corporation shall have perpetual existence.

**ARTICLE VI. PRINCIPAL OFFICE**

The initial street address of the corporation's principal office is Suite 226, 1840 West 49<sup>th</sup> Street, Hialeah, Florida 33012.

**ARTICLE VII. MANAGEMENT BY SHAREHOLDERS**

The corporation shall be a close corporation within the meaning of, and governed by the Florida Close Corporation Act. The business of the corporation shall be managed by its shareholders pursuant to Section 608.72 of the Florida Statutes, and there shall be no directors.

**ARTICLE VIII. SUBSCRIBERS**


The name and address of the person signing these Articles of Incorporation as a subscriber is:

**ARTICLE IX. DISSOLUTION**

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two-thirds (2/3) of the outstanding shares of the corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him or her.

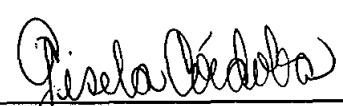
