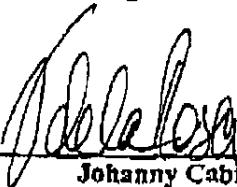
ARTICLE X-INCORPORATOR

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of incorporation, in accordance with the provisions of the Florida general Corporation Act.

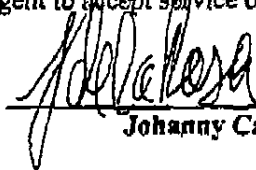
