Article I

SECRETARY OF STATE TALLAHASSEE, FLORIDA

Name. The name of this Corporation is B & C Kopp, Inc.

#### Article II

Principal Office. The address of the principal office of the Corporation is 4105 N.W. 35<sup>th</sup> Street, Gainesville FL 32605.
