ARTICLES OF INCORPORATION

OF

ARTICLE 1 - NAME

The name of this corporation shall be:

SILHOUETTE BODY & SKIN CARE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
