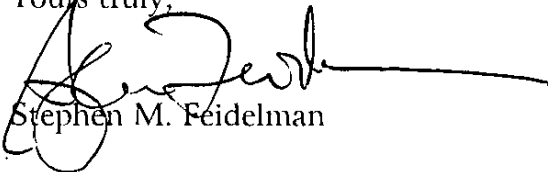

ARTICLE 1. NAME

The name of this corporation is RDG INSURANCE AGENCY,

ARTICLE 2. PRINCIPAL PLACE OF BUSINESS

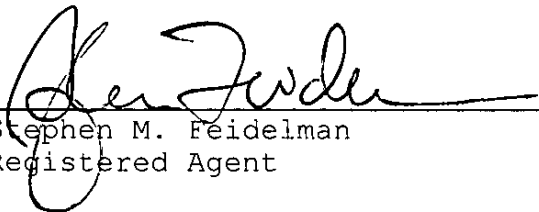
