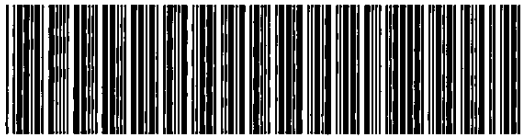




ARTICLE IX

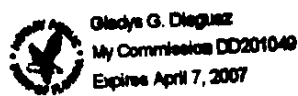
