ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is International Yacht Security and Safety, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on December 4, 2006.

ARTICLE III - PURPOSE

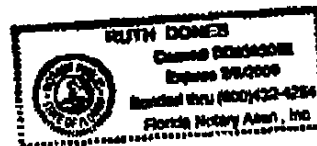
