**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF

Pursuant to Chapter 621, Florida Statutes and Section 607.1006, Florida Statutes, **DYKES EVERETT & ASSOCIATES, P.A.**, a Florida professional service corporation (the "Corporation"), does hereby amend its Articles of Incorporation to change its name as follows:

1. Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following is substituted therefor:
