ARTICLES OF INCORPORATION
For

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Abellard Detailing, Inc. Principal place of business is 3430 Pine Walk Drive North, Apartment 613, Margate, Florida 33063.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.


