ARTICLE I

NAME

The name of this corporation shall be:

SURGICAL ONCOLOGY OF SOUTH PALM BEACH, P.A.

ARTICLE II

DURATION

This corporation shall commence its existence upon the filing of these Articles of Incorporation, and shall exist perpetually unless sooner dissolved according to law.

ARTICLE IX

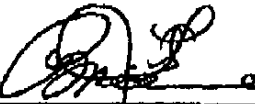
INDEMNIFICATION
