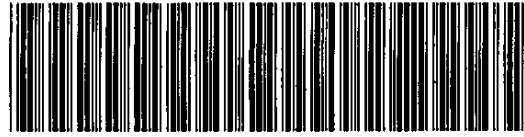

ARTICLE I. CORPORATE NAME

The name of this Corporation is: JOSE ENRIQUE GARCIA, D.D.S., P.A.

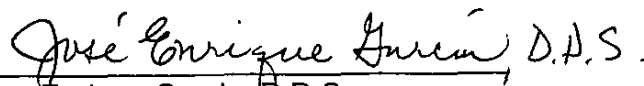
