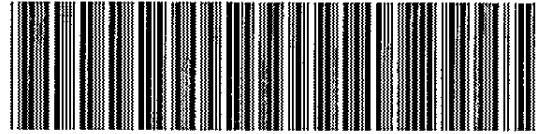

THE NAME OF THE CORPORATION IS MANA ENTERPRISES, INC.

ARTICLE II - DURATION

ARTICLE III - PURPOSE

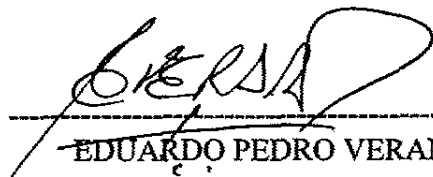

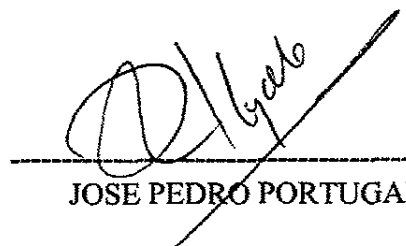
