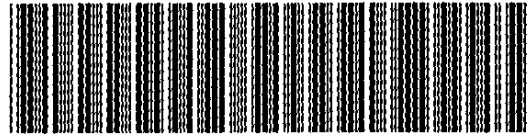

ARTICLES OF INCORPORATION
FOR
FLORIDA A/C EXPERTS, INC.

I, the undersigned, hereby organize for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provision of the Statutes of the State of Florida, providing for the formation, rights, privileges, immunities and liabilities of a Corporation for profit.

ARTICLE I - NAME

The name of the Corporation shall be:

ARTICLE II - DURATION

This Corporation shall exist perpetually commencing on the date of receipt of these Articles by the Florida Department of State, Division of Corporations.

ARTICLE III - PURPOSE

The purpose of the Corporation is to engage in any and all business of air conditioning and heating business plus any other business permitted by the laws of the United States and the State of Florida's Corporation Act.

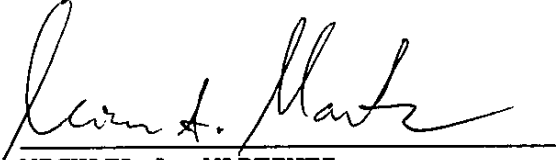
ARTICLE XIV - AMENDMENTS

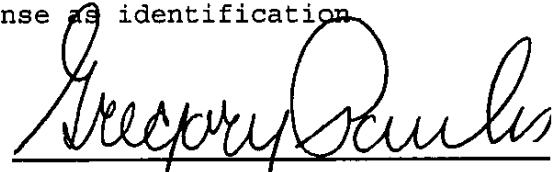
