The undersigned subscriber to these Articles of incorporation, is a natural person competent to contract, hereby associate themselves together to form a professional association under the Laws of the State of Florida providing for the formation of a corporation for profit with the powers, rights, privileges, and immunities hereinafter mentioned, and they hereby make, subscribe, and acknowledge and file with the Secretary of State of the State of Florida this Certificate of Incorporation; and to that end they do, by this Certificate, set forth the following Articles of Incorporation.

To such extent as a professional association organized under the laws of the State of Florida may now or hereafter lawfully do, to do, either as principal or agent and either alone or in connection with other professional association, corporation, firms or individuals, all and everything necessary, suitable, convenience, or proper for, or in connection with, or incidental to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interest of this professional association or to enhance the value of its properties; and in general, to do any and all things and exercise any and all powers, rights and privileges which a professional association may now or hereafter be organized to do or to exercise under the laws of the State of Florida or under any act amendatory thereto, supplemental thereto, or substituted therefore.

The foregoing clauses shall be construed as and shall be powers as well as purposes, and the matters expressed in each clause shall, unless otherwise herein expressly provided, be in no wise limited to reference to or inference from the terms of any other clause but shall be regarded as independent powers and purposes; and the enumeration of specific powers and purposes meaning of general terms or the general powers of the Professional association, nor shall the expression of

This professional association shall be authorized to exercise and enjoy all other powers, rights and privileges granted by the laws of the State of Florida to a professional association organized there under, and all the powers conferred by all acts heretofore or hereafter amendatory of supplement to that statute, and the enumeration of certain powers as herein specified is not intended as exclusive of or as a waiver of any of the powers, rights or privileges granted or conferred by the statute now or hereafter in force; provided, however, that nothing herein contained shall be deemed to authorize or permit this professional association to carry on any business, to exercise any powers, or to do act which a professional association formed under that statute may not at the time lawfully carry on or do.

The maximum number of shares of stock that this professional association is authorized to have outstanding at any time is One hundred (100) shares of stock of \$1.00 par value each.
