THE UNDERSIGNED, acting as sole incorporator of Abbott-Enterprises, Inc., under Chapter 607 of the Florida Statutes hereby adopts the following Articles of Incorporation for corporation:

ARTICLE I

Name and Office

The name of the corporation shall be Abbott-West Enterprises, Inc., and the corporate address shall be 2297 Cliffdale Street, Tallahassee, FL 34761.

Duration

The duration of the corporation is perpetual.
