The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

### **ARTICLE I - NAME**

### The name of the corporation is MRI BUSINESS BROKERAGE, INC.

### ARTICLE II - PRINCIPAL OFFICE
