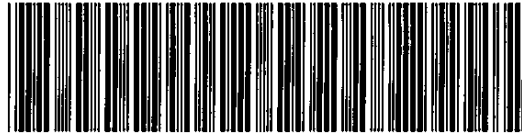

ARTICLES OF INCORPORATION

OF

ARTICLE I – NAME

The name of this Corporation is:
