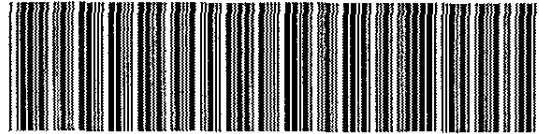

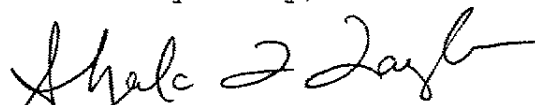

**ARTICLE I**

The name of this corporation is: **SAULS RENTAL PROPERTIES, INC.** The principal address and mailing address of this corporation is 5513 Meadowlark Lane, Milton, Florida 32570.

**ARTICLE II**

The purpose of this corporation is for the ownership and management of rental properties and any and all other lawful business.

**ARTICLE III - CAPITAL STOCK**

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

**ARTICLE IV - PRE EMPTIVE RIGHTS**

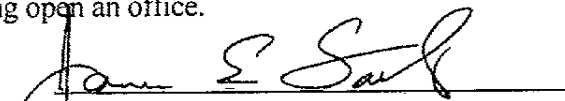
