# ARTICLES OF INCORPORATION OF <u>The NTC Clinic, P.A.</u>

The undersigned incorporator, a natural person competent to contract and a  $\overline{\succ}^*$ Doctor of Medicine, duly licensed to render services as such under the laws of the State of Florida, hereby forms a corporation for profit under the Professional Service Corporation Act and other laws of the State of Florida.

# ARTICLE I - NAME AND PRINCIPAL OFFICE OF CORPORATION

The name of this corporation shall be The NTC Clinic, P.A. The principal office and mailing address for this corporation shall be 1101 Citrus Tower Boulevard, Clermont, Florida 34711.

# ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

A.
