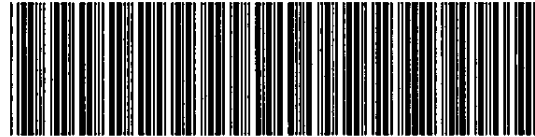

These Articles of Incorporation are being filed pursuant to Section 607.1115 of the Florida Business Corporation Act, as amended, in connection with the conversion of Homerescuesolutions.com, LLC, a Florida limited liability company, to a Florida corporation. FOURTH. The total number of shares that the corporation is authorized to issue is One Thousand (1,000) shares of Common Stock, \$.01 par value per share.


