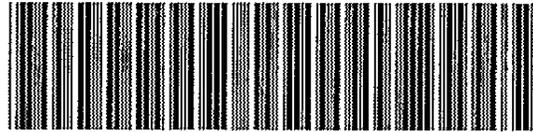

NAME OF COMPANY**
