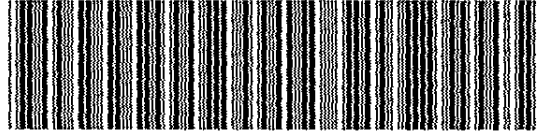

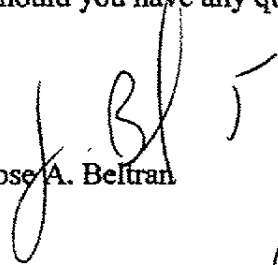

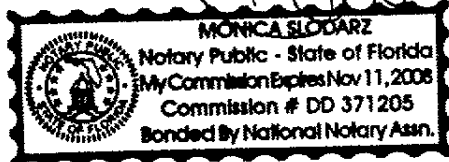

Back on November 2005 we inadvertently filed articles for a "non profit" rather than a "profit" Florida Corporation.

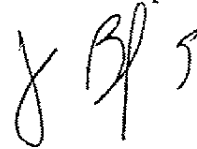

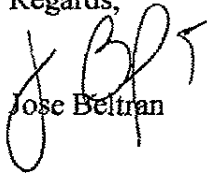

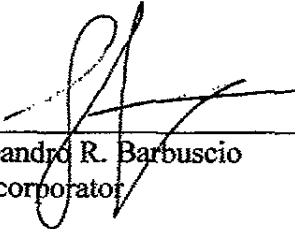
