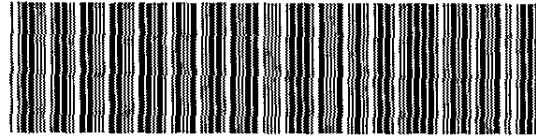



**ARTICLE ONE**

The name of the corporation is GRUSZYNSKI & JAMES, P.A.

**ARTICLE TWO**

The principal place of business and mailing address of the corporation shall be Suite 200, 10150 Highland Manor Drive, Tampa, Florida 33610.

**ARTICLE THREE**

The effective date of said incorporation shall be January 1, 2007, and the period of its duration is perpetual.

**ARTICLE FOUR**

The purpose for which the corporation is organized is (a) to engage in the practice of law as a professional law corporation and to carry on services incidental to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this corporation; and (b) to own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation. The number constituting the initial Officers / Directors is two (2) and the names and addresses of these are:


