

ARTICLES OF INCORPORATION

OF

(In Compliance With Chapter 607 and/or Chapter 621, Florida Statutes)

ARTICLE ONE

The name of the corporation is GRUSZYNSKI & JAMES, P.A.

ARTICLE TWO

The principal place of business and mailing address of the corporation shall be Suite 200, 10150 Highland Manor Drive, Tampa, Florida 33610.

ARTICLE THREE

The effective date of said incorporation shall be January 1, 2007, and the period of its duration is perpetual.

ARTICLE FOUR

The purpose for which the corporation is organized is (a) to engage in the practice of law as a professional law corporation and to carry on services incidental to the practice of law.
