ARTICLES OF INCORPORATION OF BRANCH INVESTMENT PROPERTIES, INC.

These Articles of incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, as particularly set forth in Chapter 507 of the Florida Statutes.

ARTICLE 1 NAME AND ADDRESS

The name of this corporation shall be BHANCH INVESTMENT PROPERTIES, INC. The Initial principal business address of the corporation is 3980 Fowler Street, Fort Myers, Florida 33901.

ARTICLE 2 DURATION

The corporation shall commerce upon the filling of these Articles and shall have perpetual existence thereafter.

PURPOSE

The purpose for which the corporation is organized is the transaction of any and all lawful business for which a corporation may be incorporated under the Florida. Business Corporation Act, as the same may from time to time be amended.

ARTICLE 4 CAPITAL STRUCTURE

The aggregate number of shares of capital stock which this corporation shall have the authority to issue shall be one million (1,000,000) shares of common stock, all of the same class and each having a par value of One Dollar (\$1.00). Nine hundred ninety thousand (990,000) of the authorized shares shall be designated as non-voting common stock and fen thousand (10,000) of the authorized shares shall be designated as voting common stock; with the exception of voting rights, the shareholders shall have identical rights in all other respects.
