ARTICLES OF INCORPORATION OF

We, the undersigned, jointly and severally agree with each other to associate ourselves and our successors together as a Corporation for the profit under the laws of the State of Florida, in the following Articles of Incorporation to wit:

ARTICLE I

The corporate name shall be ZEN FITNESS, INC.

ARTICLE II

The Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III

1. The number of shares authorized capital stock of the Corporation shall be seven thousand five hundred (7,500) shares of common stock with a nominal par value of One Dollar (\$1.00) each.

2. The Capital Stock may be paid for in property, labor, services or cash at a just valuation to be fixed by the stock holders. All of such stock shall be fully paid and non assessable.

ARTICLE IV

The amount of capital with which this Corporation will begin business shall not be less than Five Hundred Dollars (\$500.00).

ARTICLE V

The term for this Corporation shall be perpetual.

ARTICLE VI

The principal office of this Corporation shall be 5905 Pine Ridge Circle Vero Beach, Florida, 32967.
