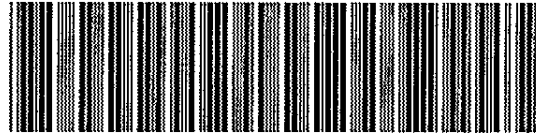

**ARTICLES OF INCORPORATION
OF
BROWARD CUSTOM FRAMES, INC.**

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this corporation is Broward Custom Frames, Inc. Its principal office address and business mailing address is c/o Fast Frame Expert Picture Framers, Lakeview Shopping Plaza, 1384 Coral Ridge Drive, Coral Springs, FL 33071.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.


